Many practitioners find it an intense experience to work with trauma survivors due to unbridled transference and countertransference that derails them from the leadership role. This experiential workshop helps you identify your own countertransference that gets triggered by stories of horror, terror, rage and despair. Some defenses may be denial, minimization, over-identification, and role reciprocity as you're pulled into the dance of trauma. Observing your projections in action creates a mirror for you to develop new skills in both professional and personal roles.

Regaining your Appropriate Authority, you then mirror for clients their transferences onto you as good/bad mother or father, et al. You'll learn the 'asocial response', interrupting the cycle of projecting the past into current relationships, along with other action methods to diffuse and work through transferences onto yourself and other group members. Using TSM in practice cases you will learn action interventions for self and group members that will keep your group healthy and high-functioning.

PROGRAM GOALS: The overall workshop goal is for participants to incorporate safe, therapeutic action methods drawn from TSM Psychodrama into their work with individuals, couples and groups who have suffered trauma. These methods include learning how to:

 provide a safe emotional and physical working space; use action techniques and structures to identify and disrupt dysfunctional patterns of transference and countertransference, and incorporate positive actions and interactions to balance those that were removed.

LEARNING OBJECTIVES: As part of group process and building sociometric connections, this workshop will provide space and time for participants to list and share their own specific goals or objectives. Participants will learn through action and practice to:

- Utilize TSM Action Safety Structures to develop group cohesion and safety
- List defenses therapists experience when working with trauma survivors
- Assess the interplay of the therapeutic alliance and its disruptions
- Identify patterns of countertransference from your own personal issues
- Identify your defenses to the clients' difficult stories
- Explain mirroring as an action intervention
- Apply the action tool of mirroring the clients' transferences back to them through role play
- Describe the asocial response (Kiesler, 1982)
- Use the asocial response with other group members
- Identify specific steps to mark progress in personal trauma repair, if applicable
- Give examples of skills you can utilize to self-regulate during session
- Apply at least 3 TSM action interventions to your work with trauma survivors
- Utilize additional tools for professional resilience when working with trauma survivors
